## BEACHSIDE HOLIDAY PARK

### PARK RULES FOR TOURISTS

To ensure the comfort and safety of all our guests, we ask that you take the time to familiarise yourself with our Park Rules and Regulations.

#### OFFICE HOURS: 8.30AM – 6.00PM.

1. **ALL CARAVANS & CAMPER TRAILERS** are required to have the drawbar facing the road and to be placed upon the site so that it is a minimum of 1 metre off the road and 2.5 metres from the unit on the next site.
2. **ALL PAYMENTS** must be made at the office on arrival. You will NOT be admitted to the Park until your required fees are paid. Fees are non-refundable. Nightly site fee covers 2 people.
3. **ALL SITES** must be maintained in a clean and tidy condition and vacated clean and tidy. Rubbish, waste material, and debris are NOT permitted to remain in or around a site.
4. **BARBEQUE** facilities are provided please clean after use. If using your own barbeques please use ONLY gas or electric.
5. **BIKES** roller blades, scooters and all wheeled toys must be used on roadways only and NOT on pathways or around amenities blocks. The management of the Park is not responsible for any accident or injury caused whilst using such toys in the Park. All activities of this nature must cease when streetlights are activated. Normal road rules apply and helmets MUST be worn. **ALL ACTIVITIES CEASE WHEN STREET LIGHTS ARE ACTIVATED.**
6. **DAMAGE** to Parks property will NOT be tolerated, including local flora and fauna.
7. **FIRES** are prohibited within the Park.
8. **FISH CLEANING** is NOT permitted within the Park. Cleaning facilities are available at the nearby boat ramp.
9. **GARBAGE** must be wrapped in bags and placed in the garbage bins provided.
10. **RECYCLING** bins are available and we encourage recycling to minimise the impact on the environment.
11. **HAND BASINS** must NOT be used for the washing of clothes, crockery or cooking utensils.
12. **LAUNDRY TUBS** are for the washing of clothes ONLY and must be left clean after use.
13. **MOTOR VEHICLES & BOATS** only one car is permitted per site and must NOT be parked on roadways or other sites within the Park, boats and additional vehicles may be permitted but only by arrangement with the Manager.
14. **NOISE** drunkenness and offensive behaviour will not be tolerated under any circumstances. Noise likely to disturb neighbours is NOT permitted and all noise is to cease by 10.00pm sharp. Patrons are responsible for the behaviour of guests.
15. **PLAYGROUND** children under the age of 10yrs MUST be supervised by an adult.
16. **PETS** are NOT permitted in the Park **unless approved by Management**. Approved pets are strictly to remain in the dog friendly area and are not to be walked outside of the purple shaded area shown on the map.
17. **POOL** a competent ADULT swimmer MUST accompany children under 12yrs and any incompetent swimmers. Do not share pool pin code.
18. **SHOWERS & TOILETS** an ADULT MUST accompany Children under 10yrs. Do not share amenities pin code.
19. **SITES** and accommodation MUST be vacated by 10.00am on departure date.
20. **SPEED LIMITS** for the safety of all guests please keep speed limit to 10km/h at all times.
21. **SMOKING** is NOT permitted inside all buildings, within 4 metres of public buildings and within 10 metres of playgrounds.
22. **TRENCHES** must not be dug around tents or annexes.
23. **NO RESPONSIBILITY** is taken by Management or Council for personal injury, damage, or loss of property. Guests are responsible to secure their belongings at all times.
24. **GENERATORS** are NOT permitted in the Park.
25. **LIGHTING** of open flame BBQs, Braziers etc are NOT permitted within the Park.
26. **COURTEOUS AND CONSIDERATE MANNER** Park patrons should act in a courteous and considerate manner towards the Park Owner, Park Manager, Park Employees, Park Contractors and other occupants of the park.

**BREACH OF RULES** persons failing to observe, or who breach any of the Parks Rules and Regulations will be personally liable, directed from the park and may be prosecuted.

#### GUESTS INFORMATION

As BLACKSMITHS BEACHSIDE HOLIDAY PARK is in close proximity to the beach patrons should be aware of Beach conditions. The surf club post the conditions and patrons should read these before entering the surf.
